TMM's cash collections from sales grow by 35% y-o-y

Kyiv, 26 April 2013 – In **Q1 2013**, TMM's cash collections from sales of properties grew by **35% y-o-y** and amounted to **UAH 42.5 million**.

Sales in **Kyiv** and **Kharkiv** constituted 90% and 10% of the total amount respectively.

Sales in projects under construction accounted for 30% of the total volume.

The largest project TMM is currently selling properties in is a business-class residential complex Sonyachna brama (73-79 Lomonosova str., Kyiv), with the total sellable area of over 167 ths. sq m.

As reported earlier, TMM started construction of a new premium-class residential complex, Alter Ago in the center of Kyiv (7 Laboratorny lane).
